## Overview

He is regularly instructed in an advisory capacity and as an advocate in cases in which such issues arise, including confiscation and receivership proceedings before the Crown Court.

Andrew qualified as an arbitrator under the Institute of Family Law Arbitrators' financial scheme and was admitted a Member of the Chartered Institute of Arbitrators, in 2016. He has since been appointed as arbitrator, and delivered arbitral awards, in a number of cases. He has also been appointed as 'judge' / evaluator for the purposes of numerous private FDRs, and successfully assisted parties in settling a variety of complex, high value financial disputes.
