That solution can be a simple pragmatic compromise but often it is more complex with Jayne drawing from her experience to suggest more creative options, many of which would not be available to a Judge at a final hearing.

As a Barrister Jayne was regularly instructed in complex high net worth cases, often against QC's including Multi-million-pound divorce settlements. Jayne has expertise dealing with off shore trusts, landed estates, discretionary trusts, tax avoidance schemes, business valuations and inherited wealth and can offer insight and practical solutions to apparently intractable problems.
